## 4. Overview

We plan a varied and exciting programme schedule for each week. Details of each programme will be emailed to you at the start of each term. We have a Facebook page for each of the sections – if you befriend 'GSL seventeenth Gillingham' then you can be added to the relevant page - to protect our Young People, they are set to the maximum security settings, so are accessed by invite only! The Leaders use a mixture of email and Facebook to communicate with parents, so please try to check both of these regularly so you don't miss instructions or important information! There is also our Twitter feed @17thGillScout!

Events are also arranged by Gillingham District and Kent county which provide events that we may not be able to do as a group like Theme park camps and days out. These will be communicated to you, but are also posted on our district website – www.gillinghamscouts.org.uk

We will also plan special outings and events at weekends and during the holidays. The Cub leader will provide you with details and ask for your permission before members take part in any of the extra activities.

All leaders, assistants, helpers and parents/guardians are CRB checked before helping.

# 5. Joining / Membership

Our Cub section is open to all boys and girls aged 8 – 10 ½ years old. The Scout Association sets the maximum number of members allowed in each section. The Cub Section is limited to 30 members and our Cub Pack section meetings hope to run at the maximum number all the time.

As we know it can be a little daunting for our young people, we give all of our new starters the option to come along for three weeks (free of charge) to see if they will enjoy becoming a Cub. Parents are welcome to stay for the first week. They are then welcomed into the pack with a formal investiture, where they receive their scarf, woggle and badges for their uniform and make the Cub Scout promise. The joining fee for our group is £5.00 - which covers the cost of their scarf, woggle and badges.

Replacement scarves cost £3.50 and woggles are available at 20p each. Lost badges are charged at £1 each.

Our membership subscription fees are £3 per week payable at the beginning of each term. Subs are used to cover the costs of hall rent, badges, insurance, membership fees to the Scout Association, resources for activities and subsidizing the cost of visits.

Once a child is invested in our group, they will automatically receive an invitation to join the next section once they are old enough.





## 6. The uniform

Cub Scouts wear a practical smart uniform consisting of a Green Cub polo shirt and Green Cub sweatshirt, group scarf, blue activity trousers or black or grey school trouser and black shoes or trainers. Uniform is available either from Rainham Sports or online from: www.scouts.org.uk

We recommend that you obtain a larger size polo shirt and sweatshirt than you normally would to allow it to fit throughout your child's career in Cubs.

We can sometimes offer good quality secondhand uniform. Please speak to a Leader if you are interested.

If they haven't already started one, all Young People are offered the chance to start a camp blanket. These are taken on camp and are a lovely way of showing others their journey through Scouting. These are available from the group at a cost of £2.35 and more details about this item can be given by Leaders.

### 8. Location

We meet in the scout HQ on the Howard school site in Derwent Way, Rainham – attached to this document is a copy of the site map for your information.

# 9. Time keeping

We would be grateful if you could ensure that your child arrives promptly for the start of the meeting or activity – we ask that you wait in the lobby until a Leader appears at the doors, as often we only have 5-10 minutes before a session starts to organize ourselves and get resources ready!

Please note that we require at least two leaders to be present before we can take responsibility for the young people. Equally, please arrive on time to collect your child, although we do ask for you to bear with us if we are running a few minutes late!





## 10. Behaviour

All group members are expected to behave with due consideration to themselves and others. Bullying of any kind will not be tolerated. This, along with any persistent disruptive, violent or anti-social behaviour, may be dealt with by a formal warning, meeting suspension or, in extreme cases, removal from the group.

We do ask that all members and their families remember that leaders are volunteers who receive no payment for the work they do or the time that they give up to running sessions and camps, training and planning.

# 11. Payment methods

We offer three ways to pay:

Please also inform your leader via email if you pay by bank transfer as we do not have direct access to the accounts and rely on parents to tell us they have paid so we don't chase you later in the term!

- 2. We also accept cash payments, handed in a sealed envelope with your child's name, amount and what it is for written on the outside.
- 3. We also accept cheque payments (made payable to 17<sup>th</sup> Gillingham Scout Group)

#### 12. Personal Details

Please complete all consent and personal details forms for your child so that we can complete your child's membership to our scout group.

It is also important that we have details of any medical issues and food allergies so that we are aware of them when running our programmes, and for when we have them overnight at sleepovers and camps.

Please ensure we have up to date contact details to ensure that we keep you up to date with any news and information concerning Cubs and the Scout Group, or in the event of an issue or emergency.

# 13. Parental Help

Our sections can only run successfully with the active participation of the parents, whether simply by encouraging the children to join in activities or occasionally helping at a meeting.





We will also need help when we run outings or visits as, for sessions away from the HQ, we must have one adult for every eight Cubs.

If you are interested in helping the Group-whether it be as a parent helper, behind the scenes (perhaps on our executive or fundraising committees), or as a uniformed Leader, please speak to the Scout Leader. We can organize a DBS check for you and let you know about the different opportunities there are for assisting the Scouts!

We appreciate that you may only be able to help at specific events or activities, whilst others can commit to an hour or more a week – we can guarantee that there is a position suitable to your availability and would love to hear from you!

# 14. Fund raising

We occasionally participate in various activities in order to raise funds for the Group. Please get involved when we ask for assistance in this area as we can only run the activities offered to our Young People if we can afford them.

### 15. Gift Aid

At the 17th Gillingham Scout Group, we make use of the government gift aid initiative as a way of raising additional funds for the group, this helps to allow us to keep subs low and to support group / district activities and towards repairs to the HQ.

Gift Aid is a simple government initiative which allows you to increase the value of your donations (which includes subscriptions) at no extra cost to you. For every pound you give, the group can claim an extra 25 pence from HM Revenue & Customs, helping your donations go further within the group. If you are a UK tax payer, please could I ask you to complete the new gift aid form attached and return it to your sections leader in the next couple of weeks.

# **EMERGENCY AID**

In case of emergency involving my child, I understand every effort will be made to contact me. I give consent for a Scouting Leader to dispense, if necessary, common over-the-counter medicines to my child with due diligence. These medicines include paracetamol in all forms, junior basic linctus, piriton solution, antihistamine creams or ibuprofen in all forms.

# **M**EDIA CONSENT

The use of camera and video equipment is now a commonplace occurrence at Section meetings and Group events. However, the 17th Gillingham Scout Group is required to obtain written permission from a parent or guardian before using photographs or videos that contain images of their child.
